Village President's News & Notes



Economic development makes a community thrive and there are many important parts to a community's economic development.

- I'm looking forward to accelerating the local road programs to keep the village's infrastructure in good condition. This infrastructure is critical for businesses as it allows residents, employees and customers to travel through Orland Park more efficiently.
- We will continue to encourage the transformation of Orland Square Mall to position it for long term success. Historically, the mall is not only Orland Park's economic engine; it is a major driver of our regional economy.
- Additionally, we will make progress on the I-80 Corridor working with our partner communities, Tinley Park and Mokena through the Chicago Southland Interstate Alliance.

In the coming months, this group will lead new marketing efforts to drive this regional development effort.

- Completing the Master Development Agreement and beginning construction on the remainder of the Main Street Triangle Project remains a priority. Construction is expected to begin in 2020 and will be complete in three to four years.
- We will continue to lobby the state to include the widening of 143rd Street and Wolf Road in its funding program, develop a plan to rebuild and widen I-80 from I-294 to Joliet, and fund the last two phases of the CREATE Program which will provide express trains.
- The village knows the importance of its local businesses and developers and will work to reduce regulatory costs by streamlining the village's permit process and study ways to eliminate unnecessary permitting.

"Quality of life" is a familiar term used by government entities to describe their efforts to create a

premier community for residents and businesses. We have a number of quality of life tasks on the agenda for the next few years:

- Develop long term park upgrades and refurbishment plans for the village's park system
- Finish improvements at the John Humphrey Sports Complex over the next year
- Implement an outdoor concert series at Centennial Park West
- Work with local boards and associations to cooperatively enhance recreation, sports and arts programs in the Orland Park community

These goals may seem ambitious but we are ready to work together as a community to make them realities. Orland Park is one of the premier communities in the State of Illinois and we look forward to maintaining this status for residents and businesses alike.





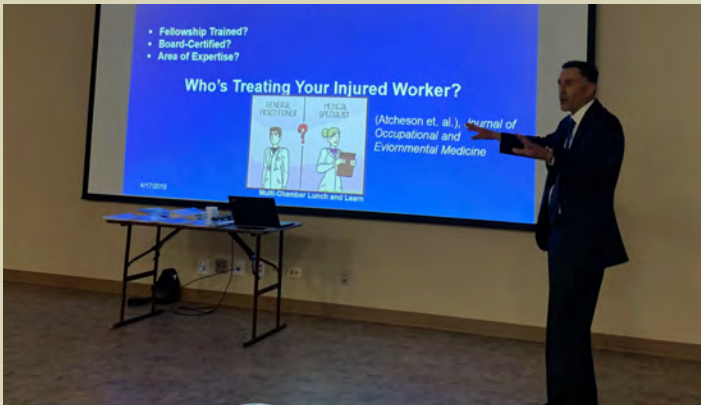
