

Mayor's Message

During the past year, the business community has faced unprecedented challenges. Our lives have been drastically altered because of COVID-19. How people do business has changed. Many of our small businesses, especially those in the service industry, have been hit especially hard by the effects of COVID-19. The Village's operations and interactions with businesses and residents have changed to enable us to continue to provide the level of services the community has come to expect in Orland Park.

Ensuring public safety and maintaining fiscal strength are two of the most important things the Village of Orland Park can do to ensure that our businesses and residents can thrive.

In January, Police Chief Mitchell gave us an update on our public safety statistics for 2020, a few are shown here:

- In 2019, the number of index crimes was the lowest in 25 years
- In 2020, index crimes dropped another 29%
- Violent crimes reduced from 26 in 2019 to 25 in 2020, both of which are the lowest number of violent crimes per capita for towns over 50,000 in Illinois
- Property crimes dropped from 948 in 2019, to 666 in 2020. This is less than half when compared to the 1,337 property crimes in 2016.
- Calls for service, which include our increased proactive business checks, were over 275,000 in 2020, up from the record high 209,000 in 2019.

Our police department does a phenomenal job of keeping us safe. We have proactively implemented several programs over the last few years to ensure that our businesses and residents are kept safe. Additionally, our department's performance during the riots and looting that occurred regionally and nationwide was exemplary.

In 2020, the Village faced several budget challenges. Our revenue dropped by over \$7 million in 2020 and we project a revenue shortfall in 2021 as well. Fortunately, since 2017 the Village reduced the operating budget by 13.9%, full time staff by 9.5% and debt by over \$40 million. This put the Village in a strong position to handle the COVID-related financial challenges without the need for drastic measures. As business owners are aware, deferring capital projects save money in the short term but cost more money in the long term. For this reason, our approach was to continue our capital program and make targeted cuts of over \$2 million where it made sense.

The result of this was increased investment in our roads and parks. In the last two years we repaved 32 road areas compared to the previous plan of 9. In the past, we were repairing one park every two years. We've changed our process and increased our investment and in 2020 the Village performed major repairs on 7 parks, repaved 10 basketball courts, 8 tennis/pickleball courts and installed 7 pavilions. Additionally, the major renovation of John Humphrey Complex was completed.

The 2021 budget includes continued increased investment in our roads and parks and a robust capital program. In conjunction with this, the Village is also taking the opportunity to restructure its debt in 2021. In total, our end of year 2021 debt will be reduced another \$4M in spite of lower revenues and increased capital spending. From the EOY 2017 to EOY 2021, the Village will have run a surplus and reduced debt by \$41 million.

In spite of the challenges over the last year, the Village of Orland Park remains in a strong position fiscally and is committed to ensure that our businesses and residents are safe.

Randy Barcella Real Estate Revealed



Tips To Say "Good Riddance" To Clutter

Say Good Riddance to clutter for the New Year. Make it your New Years' resolution to get organized and clear the clutter in your home or office. Unorganized paper records, hard drives, or other materials that contain personal data, puts you or your business at risk for a serious data breach. There many benefits of decluttering, ranging from improved organization to reduced stress, and most importantly, preventing identity theft. Saying goodbye to clutter can also be a great way to leave bad memories in the past and start the New Year fresh.

TAKE INVENTORY: Review your documents and determine what is important and what is not. If you have so much you don't know what you have and wouldn't notice missing, it's time to properly destroy. Old files, mail, financial documents, old client records, or old media files, cause overflowing file cabinets. For businesses, there are requirements to keep data for a set period of time and privacy laws for confidential information of patients and client records. Precautions are necessary to safely store or destroy these items.

GET ORGANIZED: Tackle a little bit at a time. If you try to do it all at once you will get burnt out or make mistakes. Divide into categories - 1) Important Documents, 2) Stuff You Need to Keep, 3) Items that need to be discarded or securely destroyed. Clearly label files so they're easy to locate when needed. If space is an issue, save files in a digital format. Setting up a document scanning service that digitizes your files will maximize efficiencies and clear up space. Avoid stockpiling electronics because this increases the risk of a data breach (even if you have deleted confidential information on hard drives). The safest way to reduce this risk is hard drive destruction.

SECURE YOUR INFORMATION: Practice safety in your home and office. Use hard-to-guess passwords, and place them in a secure area (NOT ON A POST-IT NOTE). Place screen locks on all devices; use physical locks on drawers, office doors, and file cabinets. For your office, do not use recycle bins. Partner with a trusted document management company that provides locked security consoles with scheduled business shredding services.

SAFELY DESTROY: So now you have your discard pile. What should you do next? Do not just throw these items in the garbage, especially items containing personal data. Securely shred documents you no longer need. Using a professional shredding company will ensure your materials go straight to the shredder and that everything is destroyed. For businesses, schedule a one-time purge or set-up scheduled shredding service. If it's from your home, you can take it to an off-site shredding facility.

So now you have the tools to start 2020 off on the right foot and say "Good Riddance" to clutter. For the future, set aside time each day to organize and practice regular purging to prevent clutter from building up.
